Anand Desai of Monteith Brown Consulting made a presentation to Council regarding the final report for the Lakefield Campground Utilization Study. Mr. Desai provided a summary of the engagement process, key considerations and the evaluation criteria. Mr. Desai advised that the preferred option has been identified as outsourcing the management of the Lakefield Campground to Otonabee Region Conservation Authority (ORCA). Mr. Desai also noted that if the Township is unable to reach an agreement with ORCA to manage the Lakefield Campground, it is recommended that a Request for Proposal be released for a competitive bidding process. Todd Brown from Monteith Brown Consulting was also in attendance to answer any questions.

Resolution No. 2021 - 206 - Lakefield Campground

Deputy Mayor Sherry Senis - Councillor Gerry Herron -

That the Lakefield Campground Utilization Study as prepared by Monteith Brown Planning Consultants be received for information; and

That the Township approve the preferred option set out in the Study to outsource the campground operation to the Otonabee Region Conservation Authority (ORCA); and

That staff be directed to commence discussions with ORCA to reach a mutually agreeable operating agreement for the Lakefield Campground commencing in May 2023; and

That in the event that a mutually acceptable operating agreement cannot be reached between the Township and ORCA, that the Township pursue a Request for Proposal/Tender for the operations of the Campground; and

Further, that the Manager of Recreation Services provide a report annually related to the Campground operations and contract to Council following the commencement of the new agreement; and

That, in response to information received through the community consultation process and best practices research, the following considerations guide the discussions with ORCA:

- the overflow area identified in the current agreement be eliminated from the campground operation;
- the existing footprint of the campground operation not be expanded;
- review the form of camping in the existing three campsite areas, including:
 - the mix of services (water, sewer, hydro);
 - site density and layout;
 - ratio of seasonal and transient sites;
- establish a vegetative buffer to delineate the perimeter of the camping area from the park/trail areas;
- establish the annual compensation amount to:
 - cover the Township's direct costs related to the Campground operation;

- provide for the ongoing contribution to other Departmental operations; and
- fund the cost of the required infrastructure upgrades;
- review options related to dockage facilities including:
 - eliminating docking facilities;
 - providing facilities for small craft docking only;
 - incorporating with other Township docking services;
- review other ancillary activities/amenities to enhance the use of the property:
 - canoe/kayak rentals;
 - concessions;
 - interpretative signage (history, culture, ecological features), lookouts;
 - educational activities;
- review campground rules to include site maintenance/aesthetics, accessory structures, over-winter storage, noise and fire regulations.
