

### **Lakefield WTP**




- Raw water Source is from the Otonabee River,
- Consists of a low lift pumping system
  - Chemical coagulation,
  - Ballasted flocculation/sedimentation (Actiflo®), dual media filtration and disinfection.
  - The plant also utilizes a granular activated carbon (GAC) contactor for taste & odour control during warm summer months.
- Aluminum sulphate is used as the primary coagulant.
- Chlorine (as sodium hypochlorite) is used for primary and secondary disinfection.
- Other chemicals used in the treatment of potable water are caustic soda and polymer (coagulant aid).
- The current rated capacity of the plant is 3,594 m<sup>3</sup>/d. The Permit to Take Water currently authorizes water taking at 2,500 L/m (3,594 m<sup>3</sup>/d).
- In 2020 the Water Plant treated 541,582 litres of raw water, which is 41% capacity

# **Management Review**

- This is a review by Top Management at PUG of the drinking water systems (Lakefield and Woodland Acres)
- Identifies any deficiencies and assigns action items to staff
- Provides a roll up report of all the activities with respect to the DWS



# Township of Selwyn Management Review



The Operating Authority (PUGSC) is required to perform a full review of the Drinking Water Quality Management System every calendar year.

The Drinking Water Quality Management Standard element 20 requires that the results of the Management Review be reported to the Owners of the Drinking Water System.

This was performed in March 2021.

- Regulatory Non-Compliance
  - Both Drinking Water Systems Receive a 100% Inspection Rating from Ministry of Environment, This was completed in February 2021.
- Adverse Drinking Water Quality Results
  - There were no Adverse Water Quality Results in 2020





# James A. Gifford Causeway

- •The first 4 phases of the Schedule C EA were completed for the James A. Gifford Causeway rehabilitation in 2013
- •An advance surcharge contract to place rock fill for the widened embankment was completed and is separate from the 2021-2023 ICIP works
- Proposed design will include:
  - Street lighting
  - Opportunities for active transportation
  - Surface water drainage improvements
  - New road platform
  - Rotary Park paving of parking lot
  - Review extension/provision of utility conduits




# Value Engineering (VE) Review


- Original EA cross section was predicated on using the existing north side sidewalk on the bridge
- Current assignment includes both the bridge widening and causeway rehabilitation
- •By considering the flexibility provided by the bridge widening we can now consider which side the active transportation (sidewalk and space for cyclists) is located
- Opportunities reviewed
  - Complete streets approach now to provide separate space for pedestrian and cyclists (preferred)
  - Advance surcharge gives space for an interim use











## Differences Between EA and Alternative Designs

#### **EA Design**

- North side sidewalk available year-round
- Cyclists share roadway platform with vehicles
- •Originally developed to tie sidewalk into existing sidewalk on Chemong Bridge (north side)

#### **Alternative Design**

- Allows use of widened and rehabilitated Chemong Bridge
- •Shared pathway along surcharge embankment separates pedestrians and cyclists from vehicular traffic
- •Eliminates active transportation crossing the road for trips to/from Bridgenorth and Rotary Park

### Benefits of Alternative Design

- Avoids any impact to the Enbridge gas main
- Reduces maintenance for sidewalk and winter deicing
- Allows multi-use pathway to be closed during winter
- Provides Complete Streets approach with separate space for vehicles and active transportation – greater safety
- Improved water quality (less area for deicing)
- •Keeps all pedestrian and cyclist traffic to natural attractions (Bridgenorth and Rotary Park) on south side of Causeway
- Utilizes the causeway embankment



Are residents of trailer parks, campgrounds, etc., eligible to vote in Selwyn municipal elections?

As per the following from the Ontario Guide for municipality voting:

#### Municipal council election

You are eligible to vote in the election for municipal council if you meet all of the following requirements:

- you are a Canadian citizen
- you are aged 18 or older
- you qualify to vote in the municipality

There are 3 ways that you can qualify to vote in a municipality:

- 1. As a **resident elector** if you live in the municipality. You may own, rent, live in shared accommodation where you do not pay rent or live in the municipality but do not have a fixed address. Being a resident elector is the most common type of eligibility.
- As a non-resident elector if you own or rent property in a municipality, but it's
  not the one where you live. You can only be a resident elector in 1 municipality.
  However, you can be a non-resident elector in any other municipality (or
  municipalities) where you own or rent property.
- 3. As the **spouse of a non-resident elector** if your spouse owns or rents property in the municipality or municipalities other than the one where you live.

Neither you nor your spouse qualify as a non-resident elector if you do not personally own or rent the property in the municipality. For example, if the property is owned by your business or your cottage is owned by a trust, you would not qualify as a non-resident elector.

I would submit to council that residents of trailer parks, etc. are part of a group that would be described in the last part as a "trust".

My concern is that multiple votes are being allowed by property owners. It's my belief that this should not be allowed as it ends up in a very undemocratic result. One person is one vote. There are other concerns such as out of region people can form factions that may not always have the best interests of the region and may only have direct interest in their camp grounds, etc. This is what is purported to have happened in Wollaston Township.

I am interested in council's response to this issue.

### September 8 Board of Health Meeting Summary

#### Dr. Salvaterra's Last Board of Health Meeting

The Board of Health expressed its sincere thanks and gratitude for Dr. Salvaterra's impressive legacy of public service in the community as Medical Officer of Health for Peterborough Public Health. The meeting took place in the newly-expanded L.I.F.E Centre at Hiawatha First Nation. Chief Laurie Carr was on hand to share her appreciation and several generous gifts on behalf of her community. Dr. Salvaterra also spoke about her gratitude for the opportunity to work as an ally with First Nations partners in their efforts to improve public health for the benefit of the community. Her last day at Peterborough Public Health will be September 19 before she moves out west to Edmonton, Alberta. Her plans to retire have been deferred in favour of accepting a new position as the Deputy Chief Medical Officer of Health for the province of Alberta.

#### COVID-19 Situational Update

Support for COVID-19 Wastewater Surveillance

Peterborough is currently experiencing the beginning of the fourth wave, with a large number of high-risk contacts being followed. Locally, almost 80% of eligible residents are now fully vaccinated. Dr. Salvaterra shared the latest <u>modelling data</u> from the Ontario Science Table. It is expected that vaccinated people will not see serious illness, but unvaccinated residents are likely to experience more severe health outcomes that could potentially overwhelm Ontario's acute care health system, as soon as October.

Each case with the Delta variant infects 6-8 people, compared to the original virus that infected 2-3 people. Unvaccinated people have a 6-fold higher risk of symptomatic COVID-19, a 30-fold higher risk of hospitalization, and a 48-fold higher risk of ICU admittance. Modelling data suggests that to blunt the fourth wave, it will require strong vaccination rates (90% of those eligible) combined with public health measures such as masking, physical distancing, decreasing social contacts, etc. Vaccination is not enough on its own. Peterborough Public Health approved its COVID-19 workplace policy requiring full vaccination against COVID-19 for all staff, volunteers and board members.

The Board of Health received a presentation about the current work underway with Trent University conducting wastewater surveillance in Peterborough and Millbrook. The Board passed a motion to advocate for provincial funding to expand surveillance to all municipal wastewater treatment facilities in the Peterborough Public Health jurisdiction, including Lakefield, Norwood and Havelock.

#### Consumption and Treatment Site Update

Dr. Salvaterra provided an update on Peterborough's Consumption and Treatment Site (CTS) application. It has received federal approval for exemption to allow drug consumption. The overseeing working group has received a building permit to begin renovating the site. The project is still awaiting word on provincial funding to actually operate the site. A media event is being planned to share the latest renovation plans, which include space for treatment, and to kick-off a local fundraising campaign.



## Re: OHIP Eye Care Resolution R2021-593

Please be advised that during their Regular Council meeting held September 7, 2021, Council passed the following resolution:

Resolution No. R2021-425

Moved by Councillor Lambshead Seconded by Councillor Franzen

**Whereas** routine eye care is critical in early detection of eye diseases like glaucoma, cataracts, and macular degeneration, and the health of eyes is critical to overall health and quality of life; and

Whereas conditions that may be detected with an annual eye exam include Diabetes mellitus, Glaucoma, Cataract, Retinal disease, Amblyopia (lazy eye), Visual field defects (loss of part of the usual field of vision), Corneal disease, Strabismus (crosses eyes), Recurrent uveitis (an inflammation of the uvea, the middle layer of the eye that consists of the iris, ciliary body and choroid), Optic pathway disease; and

**Whereas** payments from OHIP have only increased 9% over the last 30 years, which has not come close to matching inflation of costs (which include rent, staff, utilities, equipment, taxes and supplies); and

Whereas the lack of funding makes it difficult to invest in modern technology, and newer technology means earlier detection of eye disease; and Whereas the Provincial government's refusal to formally negotiate with Optometrists for more than 30 years has forced the Optometrists to absorb approximately 173 Million dollars annually in the cost to deliver eye care to Ontarians; and

**Whereas** the 2021 Ontario Budget did not address OHIP-insured eye care, Ontario Optometrists took action and voted to withdraw OHIP services starting

September 1, 2021, unless the government agrees to legally-binding negotiations to fund these services at least to the cost of delivery; and

**Whereas** this job action will jeopardize good eyecare for those who need the care of an optometrist the most and will have the greatest impact on the most vulnerable groups. Children, who's lifetime ability to learn and develop depends on good vision and to the elderly, who are at the greatest risk for vision-threatening ocular diseases;

**Now Therefore**, be it resolved that the Municipality of Trent Lakes requests that the Provincial government recognize the value that access to quality eye care brings to all Ontarians and act now to protect it; and further

**That** the Provincial government address the OHIP-insured eye care immediately and enter into legally-binding negotiations with Ontario Optometrists to fund these services at least to the cost of delivery, prior to any job action taking place; and further

**That** a copy of this resolution be forwarded to Premier Ford, Ontario Minister of Health Christine Elliot, MPP Dave Smith, MPP David Piccini, MPP Laurie Scott, to the Ontario Association of Optometrists, and to all municipalities in Ontario.
