OPP Detachment Commander Reports - SE-PSB – 2022 3rd Quarter DC, Calls for Service Report

Inspector Chris Galeazza reviewed the 3rd Quarter Report. Of note:

- The 3rd quarter has seen a decrease in violent, property and drug crimes.
- There has been an increase in calls for services pertaining to landlord/tenant disputes and mental health calls
- The OPP logged 464 hours of cruiser patrol, 3 hours of motorcycle patrol, 28.75 hours of marine patrol and 31.50 hours of foot patrol.

Police Services Board Budget Report

The Board discussed the proposed 2023 Police Services Budget and agreed that the base operational/capital budget include the following:

- OAPSB 2023 Spring Conference \$1200.00 (operations)
- Speed Awareness Board Cloud Subscription \$500.00 (operations)
- Additional Speed Awareness Board \$7000.00 (capital)
- The Board discussed the need to ensure that there are sufficient staff resources to handle an additional speed awareness board. Tania will discuss the availability of staff in the Public Works Department with the Manager and pending those discussions, a secondary speed awareness board will be included in the requested budget to Council.
- Steve brought forward the option of also using horizontal stripes along the roadside as a speed awareness tool. The horizontal stripes create the illusion that the road is narrowing and drivers intuitively slow down. Tania brought forward that Smith and Ennismore roads are generally not paved which may be problematic for painting. Tania will investigate options and report back to the Board.

Resolution No. 28/22 - Community Policing Budget 2023

That the Smith Ennismore Police Services Board recommend that expenses related to the cloud based subscription costs for the speed awareness board data be incorporated into the base operating budget for Department 11; and further that pending discussion with the Public Works Department regarding the availability of staff resources to install and maintain a secondary speed awareness board, that Council considers including an additional \$7000 in the 2023 capital budget to purchase a secondary portable speed awareness board and the necessary mounting equipment.
