- Home Energy Efficiency Checklist shared in Township e-newsletter, which included low-cost actions that homeowners could take to improve energy efficiency and reduce emissions
- Promotion of webinars from agencies including ICLEI that provide information about a variety of sustainable adaptation programs; and

Whereas the County of Peterborough Climate Action Committee has discussed the development of a marketing strategy to raise awareness about the available resources and supports offered by GreenUP programs including energy retrofits/audits; and

Whereas the 2023 Community & Corporate Services Department work plan includes the provision to source grant funding, such as the Federation of Canadian Municipalities Green Municipal Fund, for the preparation of a feasibility study to explore a sustainable development program to incentivize energy efficiency in residential homes such as a home energy loan program; and

Whereas the goal is to develop an incentive program that would examine HVAC system alternatives including ground and air source heat pumps, lighting, EV readiness, building envelope upgrades etc....as well as possible grants, loans and incentives that could assist a homeowner to implement energy efficient options, including promoting existing financial supports for heat pump technology;

Now therefore that this information be provided to Mr. Hanchet to demonstrate the Township's efforts related to energy alternatives and initiatives.
