That the Province provide financial supports and other resources to conduct this mapping exercise; and

That following the results of the mapping exercise that appropriate severance policies be developed by municipalities based on this mapping; and

That Selwyn Township support specific comments related to rural employment lands and water and wastewater capacity assessments, as noted in the May 23, 2023 report; and

That Selwyn Township support removing the Natural Heritage Systems mapping from any further versions of the PPS and instead use *Kawarthas*, *Naturally Connected* mapping; and

That Council direct staff to forward a copy of this report along with this recommendation to the Minister of Municipal Affairs and Housing through the ERO website and our local MPP as the Township of Selwyn's formal response on the draft Provincial Planning Statement.
