A public meeting commenced at 1:30 p.m. Township Planner, Per Lundberg announced that the Township of Selwyn is holding a public meeting to consider an application to amend the Comprehensive Zoning By-law for the Township of Selwyn, in accordance with Section 34 of The Planning Act. The prescribed notice of the public meeting was provided by prepaid first class mail to all residents within a 120 metre radius of the subject property as well as by way of a

sign being posted on the property. The notice was provided to the prescribed ministries and agencies via email and was also available on the Township website. If a person or public body does not make an oral submission at the public meeting or make a written submission to the Township of Selwyn before the Zoning By-law is passed the person or public body is not entitled to appeal the decision of the Council of the Township of Selwyn to the Ontario Land Tribunal, nor can a person or public body be added as a party to the hearing of an appeal before the Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so. In order to be notified of the decision of the Township of Selwyn on the proposed Zoning By-law Amendment, a written request must be made to the Township.

A public meeting commenced at 1:30 p.m. to consider an application to amend the Township's Comprehensive Zoning By-law in accordance with Sections 34 of The Planning Act. The amendment relates to the property described as Part of Lot 8, Concession 10 in the Ennismore Ward having the municipal address of 626 Mallard Drive. It was noted that the Zoning By-law Amendment application proposes to amend the Rural Residential (RR) Zone applicable to the subject lands to permit a home occupation (office use) in a detached garage. The subject property will be rezoned to the Rural Residential Exception 601 (RR-601) to permit the proposed home occupation office use as well as to grant setback, height and accessory lot coverage relief for the proposed new garage/home office building. Mr. Lundberg noted that Peterborough Public Health, the Kawartha Pine Ridge District School Board and the County of Peterborough Public Works Department have submitted comments of no concern. The Otonabee Region Conservation Authority (ORCA) has submitted comments of no concern stating that ORCA permits will be required within any ORCA regulated areas on the subject lands. It was also noted that based on a review of the floor plan for the office area submitted with the zoning amendment application, the Township of Selwyn Building Department has provided comment that the proposed office space will need to be considered as a second dwelling unit for building permit purposes. A second-unit licence will therefore be required in addition to the zoning amendment. The applicant's planner Kevin Duguay summarized the application and was available to answer any questions. The applicant, Mr. Dimalta, was also in attendance. There were two (2) members of the public in attendance in person and four (4) members in attendance virtually. The meeting concluded at 1:39 p.m.

Whereas the federal government provides for an annual grant, called Canada Summer Jobs, to support the hiring of summer students; and

Whereas the Library, Parks and Recreation and Administration Departments have applied and been successful in obtaining this funding in the past which has provided valuable summer employment opportunities and further rely on this funding to support its operations and programs; and

Whereas in 2023, the Selwyn Public Library, as well as other libraries in Peterborough County, did not receive this federal funding valued annually (Selwyn's case) at approximately \$6,300, and did not learn that funding was not approved until mid July and that given the late notice had to use fundraising dollars to fund summer students to support library programming;

Now Therefore that correspondence be sent to MP Michelle Ferreri urging her to support the Canada Summer Jobs program and provide greater access to libraries within Peterborough County who rely on this grant to fund student employment that supports valuable library programming.
