# Resolution No. 2023 – 222 – Chamber Lease and Future use of 12 Queen Street, Lakefield

That the report of the Economic Development Coordinator regarding the lease with the Peterborough & Kawartha Chamber of Commerce and the future use of 12 Queen Street, Lakefield be received for information; and

That the Township of Selwyn provide notice to terminate the current lease agreement with Peterborough & Kawartha Chamber of Commerce (the Chamber) effective November 30, 2023 and that staff be authorized to execute the mutual termination agreement and execute a new mutually beneficial lease commencing December 1, 2023 to be negotiated with the Chamber; and

That the Township assume tenancy management of 12 Queen Street for businesses and entrepreneurs as a business hub with office space and boardroom rentals available to businesses/organizations in the community; and

That staff be authorized to execute lease agreements of one year or less with potential tenants of 12 Queen Street based on the estimated annual operating costs and that following the first year, Council be provided with an update related to the tenancy management of 12 Queen Street; and

That the building assume its original name and be referred to as "The Old Post Office".

Township Planner Per Lundberg announced that the Township of Selwyn is holding a public meeting to consider an application to amend the Comprehensive Zoning By-law for the Township of Selwyn, in accordance with Section 34 of The Planning Act. The prescribed notice of the public meeting was provided by prepaid first class mail to all residents within a 120 metre radius of the subject property as well as by way of a sign being posted on the property. The notice was provided to the prescribed ministries and agencies via email and was also available on the Township website. If a person or public body does not make an oral submission at the public meeting or make a written submission to the Township of Selwyn before the Zoning By-law is passed the person or public body is not entitled to appeal the decision of the Council of the Township of Selwyn to the Ontario Land Tribunal, nor can a person or public body be added as a party to the hearing of an appeal before the Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so. In order to be notified of the decision of the Township of Selwyn on the proposed Zoning By-law Amendment, a written request must be made to the Township.

A public meeting commenced at 1:38 p.m. to consider an application to amend the Township's Comprehensive Zoning By-law in accordance with Section 34 of The Planning Act. The amendment relates to the property described as Part of Lot 12, Concession 4 in the Ennismore Ward having the municipal address of 899 Settlers Trail. It was noted that the Zoning By-law Amendment application proposes to amend the Lakeshore Residential (LR) Zone to Lakeshore Residential Exception 602(LR-602) and Rural Residential Exception 603 holding (RR-603(h)). The zoning amendment is a condition of consent (severance) for a new lot being processed by the County of Peterborough through County File No. B-62-23. The zoning amendment will permit reduced lot area and/or frontage, as needed, for the proposed severed and retained parcels. It was also noted that the reduced side yard setbacks to 3 metres for the proposed severed parcel will also be addressed. Mr. Lundberg noted that a holding provision has been included to accommodate the completion of an archaeological assessment as the subject lands abut the St. Martin's Pioneer Cemetery. The holding symbol will be removed once the archaeological assessment has been completed to the satisfaction of the Township of Selwyn. Mr. Lundberg also noted that The County of Peterborough Public Works Department, Peterborough Public Health and Otonabee Conservation provided comments of no concern. The applicant's planner Molly Conlin virtually attended the meeting and was available to answer any questions. There was (one) 1 member of the public in attendance in person. The meeting concluded at 1:45 p.m.
